- ii. In the case of music copyrighted by **Ateliers et Presses de Taizé**, vocal harmony of refrains and associated guitar chords may be reproduced under the terms of this licence, as well as the melody line of such refrains; **but not** cantor's verses, special choir arrangements, keyboard arrangements, and other instrumental arrangements.
