**STIPULATIONS:**

a) Annual reprint permission for songs copyrighted by Ateliers et Presses de Taizé. This licence enables the copying on paper (i.e. songs reprinted in parish bulletins, weekly song sheets, etc.) transparencies and overhead projections, **within the period covered by the licence** (see (d) below). The copies made may be used only in the parish, school or community which has purchased an annual licence and may not be sold or loaned to other organisations or individuals.

The licensing fee, based on published attendance figures, is as follows (indicate one):

c) **This permission is for words, vocal harmony of refrains, and guitar chords only.**

Cantor's verses, special choir arrangements, keyboard arrangements, and other instrumental

arrangements may not be reprinted under the terms of this licence.

d) This licence does not cover permanent copies kept for indefinite re-use. Copies made under the terms of the licence may be used only during the term of the licence and must be destroyed on its expiry, although they may be retained if the licence itself is renewed and the titles recorded in the Monthly Returns when used again.

e) Neither the words nor the music may be adapted or altered in any way.

f) The proper copyright line must appear below each copy of the song and must include: the **full correct song title**, the **name** of the composer, author, arranger and translator (as applicable), the word **Copyright** and the symbol ©, and name of the publisher, Ateliers et Presses de Taizé, concluding: **All rights reserved. Reprinted by authorisation of Calamus, licence number** (number added here.)

g) This licence does **not** cover material copyrighted by other individuals/publishers, even when that material is used in conjunction with material covered by this licence (e.g. text by the Grail), nor does it allow reproduction of printed material where the graphic copyright belongs to a publisher or other person not a party to this licence. The licensee must contact the appropriate individuals/publishers for use of any additional copyright material including graphic copyright. Graphics produced and copyrighted by Ateliers and Presses de Taizé may be used to make copies.

h) Renewal of this licence must be through a new written agreement between the parties.
