Publications Inc., The Grail (England), Hope Publishing Co., (USA), Kevin Mayhew Ltd, O’Carroll Publications, OCP Publications (including Epoch/NALR, New Dawn Music and Franciscan Communications), Team Publications, St Meinrad Archabbey (USA), The Liturgical Press (Collegetown), McCrimmon Publishing Co Ltd, Weston Priory Productions (USA), World Library Publications, Wild Goose Publications ((Wild Goose Resource Group/WGRG/ John L. Bell/Graham Maule material words only), Worth Abbey Music, James Quinn SJ (now administered by OCP Publications), individual composers (names available on application) and such others as may be added during the term of this licence.

This licence enables the copying on paper (i.e. songs reprinted in parish bulletins, weekly songbooks, etc.) transparencies and projections, **within the period covered by the licence** (see (d) below).

The copies made may be used only in the parish, school or community which has purchased an annual licence and may not be sold or loaned to other organisations or individuals.

c) i. This permission is for words and melody line only, with the exception mentioned in paragraph c ii below. With this exception, choir arrangements, organ arrangements, guitar arrangements or other instrumental arrangements may not be reprinted under the terms of this licence.

ii. In the case of music copyrighted by **Ateliers et Presses de Taizé**, vocal harmony of refrains and associated guitar chords may be reproduced under the terms of this licence, as well as the melody line of such refrains; **but not** cantor's verses, special choir arrangements, keyboard arrangements, and other instrumental arrangements. *(See note on Graphic Copyright, paragraph g below.)*

d) This licence **does not cover permanent copies** kept for **indefinite re-use**. Copies made under the terms of the licence may be used only during the term of the licence and must be destroyed on its expiry.

e) Neither the words nor the music may be adapted or altered in any way.

The licensee must contact the appropriate individuals/publishers for use of any additional copyright material including graphic copyright.
